Since the value in use of the interest in SA is higher than the fair value less costs of disposal at 31 December 2019, the Group determined the recoverable amount of the interest in SA using value in use, which is based on its share of the present value of the estimated future cash flows that the Group is expected to generate, including cash flows from the operations of SA with the implementation of strategic business plan.
