#### **Background/Description of the Disclosure**

Suntrust Home Developers Inc. ("Suntrust") has entered into an Operation and Management Agreement ("O&M Agreement") with Westside City Resorts World Inc. ("Westside") for the operation and management of the Main Hotel Casino, a 5-star hotel and casino project to be developed at Manila Bayshore Integrated City in Paranague City.

The O&M Agreement takes effect upon its execution on 4 May 2020 and has a term of until 11 July 2033, and shall be automatically extended or renewed, unless terminated earlier in accordance with the provisions of the O&M Agreement.

The O&M Agreement is among the transactions contemplated in the Co-Development Agreement, executed on 28 October 2019 between Suntrust and Westside.
